I DSI Air Helmets - Leakage of Water into Regulator

We received the attached safety flash yesterday from Divex Ltd, who are distributing the information to all potential users, who should fully check and test their equipment to ensure continued safe usage and operation.

DIVEX LTD HAVE BECOME AWARE OF A POTENTIAL PROBLEM WITH LEAKAGE INTO THE REGULATOR ON DSI HELMETS.

Divex Ltd would advise all users of KMBDSI air helmets that we have been informed of a potential problem with leakage of water into the following air diving helmets and bandmasks through the mushroom valve.

It would appear that water is entering the regulator on the above detailed helmets through the mushroom valve in the regulator. Divex, who are in contact with the manufacturer, is undertaking the investigation into the reason for this failure at this time. It is envisaged a definitive conclusion will be available within the next week (by 20th June 2002).

Divex Ltd has produced this notice to ensure all users of these helmets fully check and test their equipment to ensure continued safe usage.

The information available to date is that all helmets, with mushroom valves detailed above, that carry numbering may be suspect. Mushroom valves that are not numbered, are at this time considered fit for purpose. The numbering can be found moulded into the mushroom valve.

This is all the information available. This notice will be followed up with a final notice when more information becomes available.

In the interest of safety, I am sure that you will agree with the Divex Ltd action to distribute this notice as early as possible, even though a full detailed investigation has not been completed.
